Dear Commodore Vijay,

I hope that you are well.

I would like the problem of the mutual recognition of qualifications at appeal to IFFTI members again. I would like to make a concrete suggestion to you prior to the coming annual conference how I could imagine a solution. As I have already informed you, there are partly very big difficulties since e.g. graduates of the LDT would like to study in New York . I think that the problem can be described easily. All IFFTI members who are classified as university officially can relatively appreciate without problems the completions of a course of study under each other for a post-graduate course. Institutes such as the LDT Nagold which does not have any official university degree, e.g. can assess only with difficulty, on which standard are the LDT graduates. An assessment therefore lasts for very long. I have already personally got deep trouble through this since a graduate of the LDT wanted to study at FIT further quite specifically only at this. However, I could not tell him whether this recognizes the LDT conclusion or parts of it . I have not received any information from it to this to my deep regret from FIT till now.

It would be my suggestion that IFFTI gets active and carries out an 'assessment' of the members. IFFTI could develop a questionaire or something like this, which must be filled out by the respective institute or academy. IFFTI then would judge the study performances. A recommendation then would result from it. Of course the assessment could be cancelled differently and be established around a bachelor that e.g. the Nagold graduates must study at foreign university 9 months to receive degree. E.g. it is that way at Northwood university in the USA with which we cooperate already for 15 years. Certain graduates of the LDT Nagolds which pass through a special programme after the degree one more year even can get in directly into one Master of Business Administration programme of Northwood university.

Please regard my explanations merely 'as the first outline' which shall serve to push the discussion to the explosive topic a little.

I look forward to a speedy meeting and to many constructive conversations!

Subject: Mutual appreciation of degrees

Dear Commodore Vijay,

A Happy New Year 2007 for you and your family.

Prior to the next conference in Canada I would like to mention a problem: It is the difficulties of the mutual appreciation of degrees of the IFFTI member organisations.

It is my aim to initiate an obligatory common explanation of IFFTI which affects clear statements with regard to the recognition of qualifications. Again and again, that IFFTI members refer my inquiries direct to the appropriate department in their university. I have the impression that the employees there then have partly big problems to put the conclusion of the LDT Nagold in order. I also have the impression that the LDT Nagold is mistaken for a school of voacational education sometimes!

We as LDT Nagold are not appreciated generally as a non-state academy. However, it cannot be right that our graduates must pass through the complete documentary channel of the foreign partner university to get e.g. a Bachelor Degree. As you know, our graduates are taken on in the companies and paid also correspondingly in Germany directly after the two-year studies at the LDT like graduates of universities of applied sciences. And, our partner like e.g. the University of Northwood in Michigan, Florida and Texas allows our graduates to get an BA-Degree in between only 9 month of further studies in USA!

Dear Commodore.

I do not know exactly either how such a regulation of the mutual appreciation of degrees has to look in detail. I, however, ask you to conduct my suggestion further to the chairperson to obtain a progress here. After all, we want just to strengthen the networking under the members with IFFTI.

Of course I will not press here for a handling of the inquiry provided that only the LDT Nagold has a problem with that. I assume, however, that there are still more members who would welcome a discussion an perhaps an obligatory regulation in this matter.
