# TO RECEIVE AND DISCUSS PROPOSALS OF THE 'VISION REVIEW COMMITTEE'

- 5.1 At the last General Council Meeting, the following decisions were taken on the recommendations of the Vision Review Committee:-
  - (a) Membership Criteria is to be aligned with the 'Mission Statement'.
  - (b) The five main objectives are to be retained.
  - (c) A database of the existing exchanges between Member Institutions together with the credit norms being followed is to be prepared.
  - (d) Clause A (i) c is to be deleted.
  - (e) Research Committee is to examine way ahead on Clauses A (ii) b, c, d.
  - (f) Initiative Committee is to examine how provisions of Clauses A (iii) and (iv) are to be implemented.
  - (g) Clause B is to be deleted.
  - (h) The Chairperson of the 'Research' and 'Initiative' Sub- Committees are to forward their recommendations to Dr. Reginetta Haboucha and the Secretariat by 31<sup>st</sup> July 2007.
  - (i) Dr. Reginetta Haboucha, Chairperson, 'Vision' Sub-Committee is to forward the revised Vision, Mission and Objectives to the Secretariat by 31<sup>st</sup> August 2007 to enable its inclusion in the Agenda for the next Executive Committee Meeting.
- 5.2 The revised 'Vision', 'Mission' and 'Objectives' recommended by Dr. Reginetta Haboucha are placed at *Annexure I (page 8)*.
- 5.3 The Committee may discuss and approve the same.
- 5.4 The Secretariat had asked members to provided details of collaborations and credit norms being followed by them. Responses received from NCSU, USA, Ryerson, Canada, NIFT, India and Donghua, PR China, are placed at *Annexure II (page 11)*. This is for the information of the Committee.

The FIT project is waiting for the approval of Ministry of Education of China and is targeted at undergraduated students. The project with London College of Fashion is targeted at postgraduate students and is going to take place next year.

From the year 2003, Donghua University began collaboration with Japan Bunka Fashion Institute and started a sino-Japan program of fashion art design. The joint program aims to integrate the strengths of both the Chinese and Japanese resources and trains professionals with fashion design and techniques knowledge who will engage in the field of fashion design, production, and management.

Students in this program will study in Donghua University for two and half years. Students who pass all the courses and Japanese aptitude test can study in Japan Bunka Fashion Institute for one year when they obtain the study-abroad visa signed by Japan. The last half-year will be in Donhua University to complete their graduation project. The students will get deploma both from Donghua University and Bunka Fashion Institute if they are eligible for graduation, and the qualified students will be conferred bachelor degree by Donghua University.

So far, the program has gained good teaching result and extensive social influence.

#### Main courses

The curriculum is jointly decided by Chinese and Japanese side.

Courses at home: Japanese, Basics of Computer, Pattern, Fashion Illustration, Garment Material, Fashion Design, Basics of Fashion Technique, Fashion CAD, History of Fashion, History of Fine Arts, Introduction to Fashion Marketing, Introduction To Fashion Production, etc.

*Courses abroad:* Fashion Technique, Fashion Construction Design, Draping, Pattern Making, Fashion Quality, Fashion Merchandising, etc.

#### **Practical stage**

The practical stage includes draping practice, production technology practice, practice outside campus, graduation design, graduation show, etc.

Dear Colleagues, I have been remiss in moving forward on Initiatives Committee business, so I hope you will take the time to consider the following in time for inclusion in the October Exec Cttee meeting.

At our (albeit brief) discussions in Toronto, I believe we agreed that it would be useful to offer two travel scholarships (to the next IFFTI Annual Conference – in this case Australia) to be offered on a competitive basis to current PhD students of IFFTI institutions. This we agreed would be appropriate and in line with current IFFTI aims and the priority given to developing and sharing research in and between our institutions. I would like you to agree that I now work up criteria for selection, which I will then forward for ratification at the next Executive Committee in October 2007.

A second proposal that I would like you to comment upon has not been discussed but is for your consideration. With reference to Clause A (iii) c., 'Supporting and monitoring International Internships / placements': I would propose that we develop an agreement between IFFTI members that in effect offers support to students of members organisations who are undertaking internships/ placements in each other's countries. I am sure that there will be issues to be overcome, including possible costs. However you may feel that it is useful to start the discussion, particularly now when students are more than ever seeking opportunities for study or work experience overseas. Please let me have your comments.

Greetings to you and others on the e-mail list.

<u>Proposal 1</u>: I would support Phil's recommendation. FIT, for example, offers several Master's degrees but no Ph.D. programs. Before adopting such a policy, it would be good to know how many IFFTI members actually offer PhD. programs in the field of fashion and how many would be affected negatively if such a policy would be put in place.

Proposal 2: Internships for foreign nationals.

In the US, this may prove difficult. Having said that, it is not impossible to do but might require a written agreement between FIT and another entity—the other degree-granting institution, a foreign government, or an international organization of which the USA is a member by treaty or statute. FIT already serves Fulbright scholars under a similar agreement [we have three Fulbrights with us this semester]. Among the requirements of this new program/agreement (in addition to a charge for granting "visiting scholar" visa and a review by the US Department of State as well as, of course, the student's mastery of spoken and written English) are identification of—

- specific objectives/goals of the program and ways to measure them
- the FIT courses these students are expected to take
- each student's funding source, a substantial amount of which [over 50%] must come from other-than-student funds [the educational institution, the foreign government, the international organization].

- 9.5 A copy of the Election Bye- Laws which lay down the rules for the conduct of the elections to the Executive Committee is placed at *Annexure V (Page 29)*.
- 9.6 According to these rules, notice for the election is to be issued at least 3 months before the date of expiry of the tenure of current Executive Committee. In the present case notice will be required to be issued by end November 2007.
- 9.7 The Executive Committee may discuss and decide the procedure for election/ nomination of members to the new Executive Committee.

#### **IFFTI**

International Foundation of Fashion Technology Institutes

#### **ELECTION BYE-LAWS**

#### ARTICLE I. TITLE

These Bye-Laws shall be called Election Bye-Laws of 'International Foundation of Fashion Technology Institutes' hereinafter called **IFFTI Election Bye-Laws**.

#### ARTICLE II. PURPOSE

Rules and Regulations of IFFTI establish that the Executive Committee comprising 6 to 12 Members shall coordinate and direct the work of the Foundation. The Executive Committee Meeting would be Chaired by a Chairperson and in his / her absence by a Deputy Chairperson. Members to the Executive Committee, other than permanent members, would be elected by the IFFTI General Council. Thereafter, the new Executive Committee shall elect the Chairperson and Deputy Chairperson from amongst the Members of the newly elected Executive Committee. The Bye-Laws set out hereinafter lay down the procedure for the conduct and management of elections of IFFTI Members to the posts of Chairperson, Deputy Chairperson and Members to the Executive Committee.

#### ARTICLE III. AUTHORITY

The Memorandum of Association and Rules and Regulations of International Foundation of Fashion Technology Institutes (IFFTI) established by law the right of IFFTI Executive Committee to make, alter, amend or repeal the Bye-Laws for the Regulation and Management of its affairs. The extracts of the relevant Rules and Regulations are set out at Annexure I to these Bye-Laws. The provisions of the Election Bye-Laws set out hereunder are hereby incorporated in the Bye-Laws of IFFTI.

#### ARTICLE IV. DURATION

The duration of the Election Bye-Laws of IFFTI shall be perpetual till altered, amended or repealed according to the provisions contained in Article XI herein under.

#### ARTICLE V. DEFINITION AND INTERPRETATION

The words and expressions not defined herein shall have the same meaning as in the Rules and Regulations and Memorandum of Association of the Foundation.

#### ARTICLE VI. COMPOSITION OF EXECUTIVE COMMITTEE

The Executive Committee shall be composed in the manner given below:

- (a) Four nominees from Founding Member Institutions of IFFTI, i.e. one nominee each from Fashion Institute of Technology, USA, Hong Kong Polytechnic University, Hong Kong, Institut Francais de la Mode, France and National Institute of Fashion Technology, India. These four Member Institutions shall be permanent members of IFFTI Executive Committee and shall not retire by rotation.
- (b) Two to eight nominees from Member Institutions representing the main geographical areas, to be elected by the General Council. The Executive Committee shall define the Geographical Regions for the ensuing elections and the number of Members to be elected to the next Executive Committee from each of these regions. Every effort will be made to provide equitable Geographical Representation while electing Executive Committee Members. All the elected Members of the Executive Committee shall hold office for a period of three years each time.
- (c) One Chairperson shall be elected from amongst the Members of the Executive Committee of the Foundation. The Chairperson shall hold office for a period of two years each time.
- (d) In addition, one Deputy Chairperson shall also be elected from amongst the Members of the Executive Committee. The Deputy Chairperson shall hold office for a period of two years each time.
- (e) Such Chairperson and Deputy Chairperson shall be elected in their individual capacity. They shall continue to hold the post for the full tenure of two years, even if they are transferred from one IFFTI member institution to another IFFTI member institution during their tenure as Chairperson and/or Deputy Chairperson, provided the new member institution nominates them as the authorized representative of that institution.

#### ARTICLE VII. CASUAL VACANCY

- (a) The seat of a Member Institution of the Executive Committee shall become vacant if the Member Institution resigns or ceases to be or is disqualified as member of the Foundation.
- (b) A casual vacancy arising in the office of Executive Committee (other than that of Chairperson and Deputy Chairperson), out of the death or resignation or cessation of holding of office by the authorised representative of an Executive Committee Member Institution, shall be eligible to be filled by a fresh nomination by the member institution, which is eligible to make the nomination. The authorised representative so appointed shall hold office for the remainder of the term of the nominated member in whose place he / she is appointed.

- (C) Any casual vacancy arising in the office of Chairperson shall be filled by the Deputy Chairperson.
- (d) Any vacancy arising in the office of the Deputy Chairperson shall be filled by fresh election at the next EC Meeting.
- (e) All other vacancies in the offices of elected members shall be filled by fresh elections.

#### ARTICLE VIII. NOMINATIONS TO ELECTIONS

#### (a) DATES

The Executive Committee shall decide and notify at least 3 months before the date of expiry of the tenure of the current Executive Committee, the dates for filing and withdrawal of nominations to the elections.

#### (b) INVITATION

The Secretary of the Foundation shall issue a notice to all members calling for nomination to elections. The notice shall be issued as soon as possible after the Executive Committee decides the dates for various stages of nominations to elections and will include the number of the Executive Committee Members to be elected from each Geographical Region.

#### (c) ELIGIBILITY CRITERIA

- (i) <u>Executive Committee.</u> All 'Regular' Member Institutions of the General Council shall be eligible for nomination to election to the Executive Committee.
- (ii) <u>Authorised Representative.</u> Member Institutions desirous of becoming a Member of the Executive Committee shall nominate one authorized representative to represent the Institution on the Executive Committee. Member Institutions that are elected to the Executive Committee are to, as far as possible, not change the nominated representatives for the next three years and encourage participation of such representative in all IFFTI activities including the Executive Committee and General Council Meetings.
- (iii) <u>Chairperson and Deputy Chairperson.</u> All authorized representatives of the IFFTI Executive Committee Member Institutions shall be eligible for nomination to election for the posts of Chairperson and Deputy Chairperson. Once elected the Chairperson and the Deputy Chairperson would be expected to, as far as possible, attend all IFFTI Executive Committee and General Council Meetings.
- (iv) Any Institution which is in arrears in respect of Membership dues or any other dues of the Foundation on the date of making the nomination shall not be eligible for nomination to elections.
- (v) A nominee shall continue in office at the pleasure of the nominating Institution.
- (vi) A retiring member shall be eligible for re-election.

#### (d) PROCEDURE

- (i) The nomination papers would be scrutinized by the Secretary.
- (ii) Secretary shall endorse on each nomination paper whether the nomination meets the laid down criteria or not.
- (iii) Secretary shall record a brief statement of reasons if the nomination does not meet the laid down criteria.
- (iv) The nomination forms, together with the observations of the Secretary, shall be placed before the Executive Committee for decision. The Committee shall refuse or reject a nomination if it is satisfied that:-
  - (aa) the nominee was ineligible to stand for election; or
  - (bb) the member institution was not qualified to subscribe to the nomination; or
  - (cc) there has been a failure to comply with the provisions of these Bye-Laws.
- (v) In case where the nomination of a Member Institution/nominee has been refused or rejected by the Executive Committee, the Secretary of the Foundation shall give notice of the decision of the Executive Committee, together with a brief statement of the reasons thereof, to the Member Institution and/or nominee, as the case may be, by post.
- (vi) On completion of the scrutiny of the nominations, the Secretary shall, forthwith prepare a list of valid nominations and send a copy of the list to each nominee who had filed his/her nomination and to each Member Institution nominating such nominee,
- (vii) The list shall contain full names in alphabetical order and the addresses of the validly nominated Member Institutions/nominee for each Region.

#### (e) NOTIFICATION TO VOTERS

- (i) The Secretary of the Foundation shall omit from the list of valid nominations, the names of Member Institutions/ nominees who have withdrawn their candidature and send the final list of nominations to all IFFTI Member Institutions and officials contesting elections for the Executive Committee.
- (ii) The list shall contain or be accompanied by the particulars concerning the Member Institutions/nominees, to the extent supplied by the nominating member institution in Nomination Form
- (iii) The particulars contained in or accompanying the list of nominations as aforesaid shall prominently indicate that they are compiled on the basis of the particulars furnished by the Member Institution in Nomination Form and that no responsibility is accepted as to the veracity of the said particulars.

#### (f) WITHDRAWAL OF CANDIDATURE

(i) A Member Institution/ nominee may withdraw its/his/her candidature by notice in writing and delivered to the Secretary of the Foundation before 5.00 P.M. of the 15<sup>th</sup> day following the date of issue of the communications for elections.

(ii) A nominee who has withdrawn his/her candidature shall be ineligible to cancel his/her withdrawal.

#### (g) CESSATION OF MEMBERSHIP

If a nominee ceases to be in the employment of the Member Institution or the Member Institution ceases to be a Member of IFFTI (before the date of election but after the date fixed for the withdrawal of candidature) and his/her/its nomination is or has been accepted as valid, the election shall be conducted among the remaining Member Institutions/nominees for that post and no fresh proceedings with reference to the election for the post for which such Member Institution/nominee was contesting, shall be commenced.

#### ARTICLE IX. MEMBERS ELIGIBLE TO VOTE

All Regular Member Institutions of the IFFTI General Council are eligible to vote provided they are not in arrears in respect of Membership dues or any other dues of the Foundation on the date of voting.

#### ARTICLE X. ADMISSIBLE NUMBER OF VOTES

A Regular Member Institution, which is entitled to vote, shall have one vote only for each category of nominations.

#### ARTICLE XI. ELECTIONS

#### (a) MODE

- (i) The election shall be by secret ballot at the Annual General Council Meeting for the Elections to the Executive Committee, and, at the Executive Committee Meeting for elections to the posts of Chairperson and Deputy Chairperson. The authorized representative of the Member Institution shall record his/her vote personally on the ballot paper provided for the purpose.
- (ii) The Member Institution which is unable to depute its representative to attend the Annual General Council Meeting/Executive Committee Meeting in which elections are held, may cast its vote(s) by sending its Ballot Paper(s), duly completed and signed by the authorized representative in a sealed envelop to the Secretary of the Foundation. Such postal ballot papers would be presented by the Secretary in the sealed state to the Chairperson at the time of elections. The Chairperson would open the sealed ballot papers along with the votes cast by the Members at the Annual General Council Meeting.

#### (b) RETURN OF BALLOT PAPER BY A VOTER

Where a voter after obtaining a ballot paper, chooses not to vote, he/she shall return the ballot paper to the Secretary and the ballot paper so returned, shall then be marked as "Cancelled – Returned" and kept in a separate envelope set apart for the purpose and a record shall be kept of all such ballot papers.

#### (c) COUNTING OF VOTES

A list shall be drawn up for each post/region listing the Member Institution(s) / nominee(s) in the descending order of votes received. The list shall be signed by the Chairperson.

#### (d) PROCEDURE IN CASE OF A TIE

Where after counting of votes, a tie is found to exist between any Member Institutions/nominees, lots shall be drawn and the successful Member Institution/ nominee shall be considered to have received an additional vote and shall be declared to be duly elected.

#### (e) SCRUTINY OF VOTES

The Chairperson shall be assisted by the Secretary in scrutiny of the voting papers and counting of votes.

#### (f) NOTIFICATION OF RESULTS.

The names of all the Member Institution(s) / nominee(s) declared elected, shall be notified by the Chairperson.

(g) ACCIDENTAL OMISSION ETC.

No election shall be deemed to be invalid merely by reason of any accidental irregularity or informality in the conduct of the election, including accidental omission to send or delay in sending or non-receipts of any notices or documents by a voter.

ARTICLE XII. AMENDMENTS

IFFTI Election Bye-Laws may be added to, amended, or repealed by 3/5<sup>th</sup> majority of the Members present and voting at an Annual General Council Meeting.

#### EXTRACTS OF THE RULES & REGULATIONS RELEVANT TO ELECTION BYE-LAWS

#### 10. EXECUTIVE COMMITTEE

#### (a) Minimum and Maximum Strength

The total number of members of the Executive Committee shall at any time be not less than six and not more than twelve unless otherwise determined by the General Council of the Foundation.

#### (b) The First Office-Bearers/Members

The first office Bearers/Members of the Executive Committee shall be as set out in the Memorandum of Association of the Foundation.

#### (c) Composition

The Executive Committee shall be composed in the manner given below:-

- (i) Four nominees from Founding Member Institutions of IFFTI, i.e. one nominee each from Fashion Institute of Technology, USA, Hong Kong Polytechnic University, Hong Kong, Institut Francais de la Mode, France and National Institute of Fashion Technology, India. These four Member Institutions shall be permanent members of IFFTI and shall not retire by rotation.
- (ii) Two to eight nominees, representing the main geographical areas, to be elected by the General Council in accordance with the By-laws framed by the General Council. The geographical areas shall be defined in accordance with the guidelines defined by the Executive Committee.
- (iii) The nominee of the member institution hosting the next Annual Conference shall be Ex-officio member of the Executive Committee, if that institution is not already represented in the Executive Committee.
- (iv) The Executive Committee may co-opt not more than two members as Executive Committee Members, on such terms and conditions and for such periods not exceeding in any case more than one year at a time, as may be thought fit by the Committee.
- (v) A Chairperson, elected by the Executive Committee from amongst the members of the Executive Committee.
- (vi) A Deputy Chairperson, elected by the Executive Committee from amongst the members of the Executive Committee.

- (vii) The outgoing Chairperson may be additionally co-opted as the Member of the Executive Committee by the Executive Committee for such tenure as the Committee may deem proper but in any case for a period not exceeding two years provided that such an arrangement does not entail any financial implications for the Foundation.
- (viii) Each nominee of a Member Institution, on the Executive Committee shall meet the qualifications and criteria for being the authorised representative of the Member Institution represented, as laid down in the Bye-Laws made by the General Council for representing in the General Council Meetings.
- (ix) A nominee shall continue in the office at the pleasure of the nominating institution. The nominating Member Institution shall be at liberty to revoke the nomination and nominate another person in his / her place at any time.
- (x) The Secretary of the Foundation shall be non-voting Ex-officio Member-Secretary on the Committee.

#### (d) Tenure of Office and Retirement

- (i) Nominees of 4 Founding Member Institutions, namely, FIT USA, HKPU Hong Kong, IFM France and NIFT, India, shall be permanent members of the Executive Committee and shall not retire by rotation.
- (ii) All the other elected Members of the Executive Committee shall hold office for a period of three years each time. The Executive Committee Members, except the Chairperson and the Deputy Chairperson, shall retire on the date of respective Annual General Meeting. At the second Annual General Meeting held after registration of the Foundation, these members to be appointed pursuant to this Rule shall be elected to the Executive Committee. The Chairperson and the Deputy Chairperson shall retire on the date of the next Executive Committee meeting to be held after the Annual General Meeting at which the Executive Committee is elected. Thereafter, the new Chairperson and the Deputy Chairperson shall be elected at the same meeting by the new Executive Committee.
- (iii) The Chairperson and the Deputy Chairperson shall hold office for a period of two years each time.

#### (e) Eligibility for Election

- (i) Such officers of a member institution, who fulfill the criteria for being an authorised representative of an institution for representation in the General Council under the By-laws of the Foundation, shall be eligible for nomination to election.
- (ii) An institution who is in arrears in respect of membership dues or any other dues of the Foundation shall not be eligible for nominating its authorised\_representative for election.
- (iii) A retiring member shall be eligible for re-election.

#### (f) Nomination for Elections

The General Council shall in the Bye-Laws to be framed by it, lay down the rules and the procedure to be followed for nomination for election and the time frame within which the nomination has to be made.

#### (g) Casual Vacancy

- (i) The seat of a Member Institution of the Executive Committee shall become vacant if the Member Institution resigns or ceases to be or is disqualified as member of the Foundation.
- (ii) A casual vacancy arising in the office of Executive Committee (other than that of Chairperson and Deputy Chairperson), out of the death or resignation or cessation of holding of office by the authorised representative of an Executive Committee Member Institution, shall be eligible to be filled by a fresh nomination by the member institution, which is eligible to make the nomination. The authorised representative so appointed shall hold office for the remainder of the term of the nominated member in whose place he / she is appointed.
- (iii) Any casual vacancy arising in the office of Chairperson shall be filled by the Deputy Chairperson.
- (iv) Any vacancy arising in the office of the Deputy Chairperson shall be filled by fresh election at the next EC Meeting.
- (v) All other vacancies in the offices of elected members shall be filled by fresh elections.
- (h) Powers And Duties of the Executive Committee
  - (i) frame Regulations and By-laws for the conduct of the affairs of the Foundation in terms of delegation by the General Council and to add to, amend, or repeal them from time to time;

#### 20. BY-LAWS

The General Council shall be empowered to frame, amend, repeal the By-laws in respect of any matters involved in the functioning of the Foundation.

- 10.2 The Committee to decide the procedure for election/nomination of the new Chairperson and the Deputy Chairperson.
