DRAFT PAPER Chair's Update for IFFTI Executive Committee meeting

Further to our meeting in Singapore, a number of the matters discussed have been followed up, as detailed in this brief overview.

1. IFFTI Office

As raised in Singapore, Pearl has asked for the IFFTI office to be relocated out of Delhi – the chair has written to request that this is delayed whilst other options are explored. In the meantime, Commodore has visited NIFT to explore the possibility of moving the Delhi IFFTI office to be based at NIFT. We are awaiting a response.

2. Secretariat

On behalf of the Executive Committee, and following discussions with the Chair and Treasurer, Souraya has explored a number of options with regard to the future of the IFFTI Secretariat and the ways the monies etc are deposited and how the IFFTI Secretariat might operate in the long term. A paper relating to this has been circulated and there will be discussion at the meeting on Tuesday, with follow-up once Souraya has arrived on Thursday.

3. Executive Committee

In view of the fact that the Executive Committee doesn't fully reflect the number of members now that IFFTI has expanded, a further request for new membership of the Executive was sent out and I am pleased to report that UoM and Pearl have been elected onto the committee.

All of the developments above illustrate the fact that as IFFTI has expanded, we need to consider how the Secretariat is structured and how we carry forward a number of initiatives without over-burdening either the Secretary-General or some of the members of the subcommittees.

4. Subcommittee membership

I am delighted to report that Robert Ott has agreed to chair the Education Initiatives Subcommittee and has begun to explore a number of new ideas for the future.

Barbara Bundy kindly agreed to chair the new subcommittee which will focus on our industry relationships and she has begun to set out the Terms of Reference.

The Research Subcommittee, chaired by Robyn Healy, requires further discussion by the Executive. As IFFTI's membership has expanded and our expectations around research have risen, the work and responsibilities placed up on the Chair and members of this subcommittee has expanded considerably and I am concerned this cannot be sustained in the long-term. It is therefore important we give consideration to how best to structure this aspect of our work going forward to ensure we are able to continue to provide the level of support member institutions need in relation to reviewing and approving research papers.

5. Conference planning

Further to our discussion in Singapore, I wanted to reiterate the importance of careful planning in terms of conference dates to ensure we avoid clashing with Easter.

I also feel some clarification of the complexities of hosting the IFFTI conference might be useful with our expanded membership. It might be helpful for us to consider updating our conference guidelines, as well as considering possible visits to potential host institutions taking place before conference hosts are agreed.

Dear Souraya,

Thank you for confiding in me and sharing your concerns on IFFTI governance in India and the manner in which you believe the organization needs to function in a transparent manner.

Since I have worked in and know the foundations, trusts and charity sector in India very well as also have knowledge and understanding of the manner in which various Indian regulations govern the functioning of an Indian entity with foreign trustees, I am sending this note to you in somewhat detail.

My objective is to help you take effective and corrective decisions to put the functioning of IFFTI in India on a sound footing and pathway to success. In doing so, I am happy to help you and the global executive council of IFFTI professionally. But of course, you can also utilize these recommendations to work with other people you know who can help.

If you would like my help, I am happy to complete an initial rapid assessment and present an initial findings report during my visit to Amsterdam.

I did be happy to schedule a call to speak and clarify any queries you may.

Hope the enclosed recommendations help.

Background

IFFTI is a federation of fashion and fashion technology entities worldwide and has been established in India to promote the cause of research, education, outreach and related activities in the area of fashion and fashion technology, including allied fields and disciplines. The general council (GC) and executive committee (EC) of IFFTI is drawn from multiple fashion education schools globally and it's their remit to guide the functioning of IFFTI in India. Within India, IFFTI is headed by a Secretary General.

There is concern by the GC members of IFFTI, to see that the Indian operations of IFFTI are managed to exacting standards and to have regulatory as well as financial compliance. The concern is that the GC should have confidence in financial transactions of IFFTI to support fashion research, education and the aims of IFFTI.

My Understanding

The GC of IFFTI is keen to ensure that IFFTI in India has a clean and transparent status of governance and functioning, and is compliant with all local laws and regulatory matters. A number of discussions to secure IFFTI's future going forward have begun. This is in recognition of the expansion of IFFTI membership and growing aims. It was felt that a review of the options for supporting IFFTI needed to be considered. This was the essence of discussion between Souraya and Unmesh when they briefly interacted on the matter in Amsterdam to see if IFFTI could undertake an independent assessment of the options going forward.

Interim and Initial Advice

The following are pointers to consider and discuss. A few of these have already been shared by Unmesh during his conversation with Souraya and the balance observations outlined below further provide necessary details.

- 1. Shutting down an organization in India and transferring funds overseas, especially for foundations, is a hugely complicated matter. It draws the suspicion of regulatory authorities and IFFTI could come under the scanner and protracted regulatory processes, including detailed investigation.
- 2. The rules / laws governing the transfer of funds overseas for foundations and companies are governed by two different set of regulations, which fall under the purview of entirely different ministries and departments

in the central government, thus complicating matters. Additionally, there does arise the matter of taxation and the Income Tax Department would also get involved in the assessment and evaluation.

- 3. Until and unless all other routes of re-establishing the credentials and governance of IFFTI are exhausted, the GC should not look at shutting down IFFTI and trying to effect a global fund transfer, as this could create more problems than solutions.
- 4. If indeed, after all other routes have been exhausted and found untenable, then within the ambit of the law, competent legal minds would need to be consulted to analyze the global fund transfer situation.
- 5. IFFTI global general council should evaluate the present conundrum as an opportunity to set things right and follow the route of focusing on establishing a credible and systematically governed organization. This would also be seen in good light by all stakeholders, including government authorities, who would then perhaps take a lenient view, if at all things go wrong. Since they would have seen IFFTI take correctional steps.
- 6. The fashion scene is India has been in a dynamic churn over the past decade, with multiple innovations in both core and alternate worlds of fashion and a surge in technical and technological advances. A globally connected organization such as IFFTI has plenty to gain from working with this opportunity, not only as a federation, but also from the perspective of individual institutions that are part of IFFTI.
- 7. The sustainable and slow fashion movement as well as the merging of traditional and modern fashion forms and motifs, sets India apart in a unique position of defining a new and sustained wave. IFFTI should anchor itself as a global organization effectively in this domain.
- 8. The cost of operations as well as labor is low in India compared to European, North American and Far East markets and thus IFFTI would be at a genuinely positive cost advantage, should it work effectively to route the happenings on the global fashion stage and its institutional interest in it, out of India.
- 9. Much work has already been implemented over many years to establish IFFTI. This is a huge effort and needs to be built upon.
- 10. IFFTI, in its renewed form, will benefit from a unique opportunity to re-establish its identity, thus carve out niche space for both the institution in India and the fashion institutes that support it. This is also a good time to re-established IFFTI identity which presently is subsumed under the Pearl Academy, that houses IFFTI.
- 11. The Indian corporate social responsibility environment has also seen a sea change over the years. Corporations are now mandated by law to invest in charities and foundations and the need for worthy partners is much acute than it was before. With limited financial resources in western markets, India could very well be a funding pipeline, through corporate social responsibility, for IFFTI activities. There does exist high potential for fashion designers, brands and fashion houses to collaborate on a larger platform, one that IFFTI can provide.
- 12. Overall, there does seem to be a strong case to lend support to this route as explained in the preceding paragraphs, instead of a reactive response of shutting down IFFTI and effecting fund transfer. As mentioned earlier, the fund transfer and closure route is riddled with complications that may have the potential to drag all the member institutions of IFFTI into unnecessary controversy, creating a feeling of mistrust and confusion among multiple stakeholders, both in India and globally.

Observations

I have reviewed the IFFTI website since that does seem to be only source of publicly available information. The following are my initial observations.

- 1. Despite being a foundation, IFFTI is registered on a '.com' commercial domain name. This may create confusion as to the charitable versus commercial nature of the organization.
- 2. From all available instances, IFFTI does seem to be a charitable foundation established under the India trust/society laws. A detailed evaluation of the incorporation documents will help arrive at the precise legal status. This would be important first step before deciding the next course of action.
- 3. Despite the vibrant India fashion scene which has many well know fashion designers and icons, none of them seem to have anything to do with IFFTI or vice versa. This does appear a bit strange that an organization meant for the fashion industry does not have any practitioner representation from within the country, except perhaps a few names.
- 4. The website makes no mention of a management team in country that is responsible for running day-today operations. Mention of the Secretary General name only indicates perhaps an authoritarian work culture that is focused on concentrating intensive authority in one person's portfolio of work, which in itself is a sign of bad governance.
- 5. The website does not mention in details how IFFTI is contributing to the cause of fashion research and outreach. There is some mention of conferences and call for papers, but not detailed enough to understand the progress IFFTI has achieved since its inception till date a span of 15+ years.
- 6. The website does not make a mention of annual report or regulatory/tax filings. These are a standard feature of any organizational website since it is indicative of a transparent and well managed organization.
- 7. The social media pages of IFFTI are either not available or not accessible. The website does make a mention of social media presence, but does not provide any links.

Implications

IFFTI is an excellent concept and can achieve much more and better in the world of fashion, fashion technology and research. However, the organizational strategy, operational plan, progress reportage and allied matters will need to be clearly visible to all stakeholders. While these may be in place, they need to be communicated and reinforced in a better manner.

All observations and insights mentioned in this document do need to be ratified through an assessment of organizational documentation and focus group discussions with management and staff, as well as interaction with key members of the global general council and executive committee.

However, if any of these observations do stand the test of time, basis present assessment and brief that has been provided, then there is much that IFFI needs to do to ensure a governance revamping and ensuring regulatory compliance of the highest degree.

Recommendations

- 1. Review all IFFTI regulatory and process documentation and filings.
- 2. Review annual activity reports, financial statements and audit reports.
- 3. Evaluate how the activities of IFFTI are meeting the the expectations of the general council and executive committee.
- 4. Define a revival route-map and work towards achieving short term and long term goals, with a view to ensure IFFTI continues to deliver serious work in the fashion industry.
- 5. Prepare a report on regulatory compliance and steps to be taken in cases of lacunae, if any.
- 6. Generally, create a systematic methodology for IFFTI to better utilize the funds it has received and report usage in a clear and transparent manner.
- 7. Finally, prepare a vision for the future, looking at global and local fashion trends, and set in place a process to execute the vision.

Next Steps

Frances Corner, Sylvie Ebel, Tina Guglielmino and Souraya Bouwmans-Sarraf recommend taking recommendations 1, 2, 5 and 6 forward.

PROPOSAL TO IFFTI TO GUEST EDIT A SPECIAL FASHION FOCUSED ISSUE OF THE JOURNAL OF ART, DESIGN AND COMMUNICATION IN HIGHER EDUCATION

The Journal of Art, Design and Communication in Higher Education (http://www.intellectbooks.co.uk/journals/view-Journal.id=139/) is a well-established international journal which welcomes articles relating to learning and teaching in higher education creative arts disciplines. The journal was founded ten years ago and was one of the first to offer opportunities to publish and share the emerging pedagogic research and scholarship in art, design and media related disciplines. DRAFT CONCEPT - 26 OCTOBER 2016

VISION: The United Nations Trust Fund's *Orange Label Competition: Fashion says NO to Violence against Women* will be one in a series of activities organized as a part of the UN Trust Fund to End Violence against Women (UNTF) 20th Birthday Anniversary in 2016.
