#### **1.1** Prof. Robyn Healy, Chairperson, welcomed the members and appreciated their efforts to attend the meeting despite time differences. She encouraged meaningful deliberations on the issues concerning the foundation.

#### 2. Chairs Report

**2.1** Call for Election to the Next Executive Committee - Prof. Robyn communicated the upcoming vacancies within the Executive Committee post-2024 conference, highlighting the global reach of our membership. Nominations have been received, and voting procedures will commence shortly, ensuring a democratic and inclusive selection process for our future leadership.

**2.2** Executive Committee Attendance at IFFTI Annual Conference - Prof. Robyn emphasized the necessity for full attendance by the Executive Committee at IFFTI conferences. The importance of our collective participation in this annual event. This is a key opportunity for us to come together, and show leadership for the Organisation.

**2.3** IFFTI ISSN No. 2583-875X (online) -The General Manager reported that the ISSN for IFFTI is provisional. To establish it permanently, the 2023 Annual Proceedings from Otago Polytechnic must be submitted at ISSN. The process is underway, and we anticipate a prompt completion to enhance the academic reach and credibility of our publications.



**2.4** Presentation by LCF at the next EC meeting in Feb 2024: Theme and Planning Overview for IFFTI Annual Conference 2025-Prof Robyn requested John Lau from the London College of Fashion to prepare a presentation detailing the theme and planning for the 2025 IFFTI Annual Conference. This presentation will be shared at the 62nd online Executive Committee meeting scheduled for February 2024.

**2.5** Review and Enhancement of the IFFTI Website: Prof. Robyn Healy and the Executive Committee discussed upgrading the IFFTI website's homepage to better reflect IFFTI's stature and appeal. The General Manager and Chairperson are set to collaborate on this initiative, and Prof. Liz and Aditi have offered to contribute to the redesign efforts. Prof. Healy urged all EC members to contribute ideas to the Secretariat and established website enhancement as a recurring agenda item once every year for continual improvement.

#### 3. IFFTI Logo

**3.1** Prof. Liz Barnes addressed a recent incident where an IFFTI member institution's use of the IFFTI logo in conference materials led to ambiguity. She emphasized the necessity for clear guidelines on the use of the IFFTI logo to prevent confusion about event affiliations and proposed the development of a formal logo usage policy for all member institutions.

3.2 IFFTI Logo Use Brand Guidelines: -

- The IFFTI logo is an important part of our visual identity and its use should be controlled
- Permission of the IFFTI Secretary must be sought for any individual or Organisation wishing to use the IFFTI logo beyond the Executive Committee
- Any individual or Organisation with permission to use the IFFTI logo should not change or alter the logo in any way, ideally using original artwork files1
- Approved hosts of previous and forthcoming IFFTI Annual Conferences and/or IFFTI Regional Events may use the logo with
   additional permission
- As a benefit of membership, IFFTI Member Institutions may use the IFFTI logo without additional permission to promote their Institution, for example in student recruitment or other external marketing activity, but not to promote events which are not directly related to IFFTI e.g. symposiums, colloquiums, events, conferences etc.
- Any Member or Non-Member Institute wishing to use the IFFTI logo in any of their externally facing material must seek permission from the IFFTI Secretary by requesting to do so via secretariat@iffti.org providing a brief explanation as to how the logo is to be.
- 3.3 Decision The Committee approved the proposal.

#### 4. Membership Brochure

4.1 Prof. Liz Barnes introduced the development of a comprehensive membership brochure that illustrates the ethos and advantages of being part of IFFTI. Currently, in collaboration with a graphic designer, the brochure will prominently feature the IFFTI logo and outline member benefits. The Initiative was received favorably by the Executive Committee.

#### 5. Status of Preparation 2023 Conference

**5.1** Prof. Borim Joo shared a detailed presentation on the status of preparation for the IFFTI 2024 Conference. (Attachment No1.Enclosed).

#### 5.2 Discussion on Fashion Film Awards (Review Process)-

Initially, Ewha will exclude non-compliant films from all films received. After organizing the works to be judged, Ewha will deliver the film link and evaluation sheet to each of the six judges. Judges complete the evaluation sheets individually at



their respective locations, and Ewha compiles them. Results can be discussed through virtual meetings such as Zoom or MS Teams if necessary.

Ewha requested that one judge be recommended from among IFFTI members.

**5.3** Prof.Robyn expressed gratitude to EWHA for their recent update and informed the Executive Committee about the ongoing monthly meetings with EWHA.

#### 5.4 Additional Point Discussion-

Pearl Academy proposal for a Hybrid Conference to allow more participation and possibility for all research papers to be included in the conference proceedings.

The committee deliberated on the feasibility of allowing online presentations for those institutions with a substantial number of abstracts accepted, considering the financial implications of sponsoring multiple attendees for an in-person conference. The consensus was that while the conference is primarily an offline event, provisions could be made to facilitate online presentations. This would involve allocating a dedicated room equipped with MS TEAMS technology, specifically for institutions requiring this support. This approach would not extend to live streaming the conference but would cater to the presentation needs of institutions with a higher volume of accepted submissions. The final decision on this matter will be made in the subsequent phase of planning, post-final selection. EWHA will be provided with all necessary assistance to implement this provision if it is adopted.

#### 6. An Overview of Dr. Deirdre Sato's Workshop at the 26th IFFTI Annual Conference at EWHA Womans University, South Korea

Dr. Deirdre Sato talked about the insightful session on developing international partnerships, to be held at the 26th IFFTI Annual Conference at EWHA Womans University.

She provided an extensive overview of the session which will include strategies for fostering robust international collaborations, emphasizing the significance of student and faculty exchanges as pivotal steps in identifying and shaping future alliances. The session is designed to guide institutions through the various stages of partnership development.

Her call to action was met with an encouraging response, with Prof. Liz and Aditi Srivastava expressing keen interest in participating. Their involvement promises a diverse exchange of experiences and practices, with Prof. Robyn noting the value of incorporating perspectives from different regions to enrich the dialogue.

#### 7.Membership Sub-Committee

7.1 Prof. Margo shared a detailed presentation updating on the IFFTI membership. (Attachment No.2-Enclosed).

#### 7.1 Discussions -

#### 1) Fashion Retail Academy, UK-

After evaluating FRA's application, the membership committee proposed considering an associate membership, emphasizing IFFTI's focus on research. LCF's initial support for FRA and Falmouth University's degree awarding were noted. Prof Liz suggested that the Membership Committee will review FRA's application further to ensure it meets IFFTI's standards.

#### 7.2 Membership Concerns:

#### a) Polimoda-

The Executive committee reflected on Polimoda's significant history with IFFTI, particularly its successful orchestration of the 2015 conference. Recognizing the institution's value, Prof Robyn and Dr. Deirdre suggested the need for proactive outreach to renew the relationship. It was decided to arrange a meeting with Polimoda to discuss rejoining the IFFTI fold.

#### 8.Education Initiative Sub-Committee

8.1 Prof. Jose Teunissen shared a presentation on the update on IAF. (Attachment No.3-Enclosed).



Prof. Robyn recommended showcasing selected papers and fashion films from the EWHA conference at the IAF event. This initiative aims to align with IAF's thematic focus, highlighting IFFTI's scholastic achievements.

**8.2** Prof. Jose expressed her willingness to revive the Education Committee in collaboration with John Lau, reflecting a positive step towards enhancing IFFTI's initiatives.

#### 9.Research Sub-Committee

9.1 Prof.David shared a presentation on the update on Research Sub Committee. (Attachment No.4-Enclosed).

#### **Developmental Online Session held on 4th October 2023**

Prof. David reported on the successful Developmental Session from October 4th. Attended by 63 authors, the session, facilitated by Prof. David, Prof. Anthony, and Prof. Noel, received positive feedback for its valuable guidance on various submission categories.

#### 9.2 Discussion & Deliberation on Creative Practice Submission to be considered for IFFTI Initiative Awards-

During the meeting, there was an engaging discussion on establishing criteria to gauge the rigour of Creative Practice submissions for the IFFTI Initiative Awards. Members deliberated on the continuous challenge of demonstrating research depth in creative practices, acknowledging that such submissions are not universally recognized for their research value. The committee recognized the importance of setting clear parameters for reviewers to assess the scholarly contribution of creative works.

**Outcome:** It was resolved to continue this discussion at the EWHA conference, with the aim of developing a framework for including Creative Practice submissions in the Initiative Awards.




